The usage rights to the Image(s) are granted by the Photographer to The Client on the reverse side of this Agreement.

Copyright

Ownership of copyrights over concept Artwork and drafts remain to the Designer. This includes, but not limited to; logos, symbols, compositions and copy. Unlawful use of the Artworks by The Client is strictly prohibited. Prior to payment is illegal.

Payment & Cancellation

The listed payments are accepted:

The Client will be required pay 50% of the service fee upon scheduling an appointment, which is non-refundable, and is required to pay the remaining 50% after the service has been completed.

All payments are to be made within 30 days of invoicing.

Approving Proofs

The Client is entitled to holding the responsibility of approving of designs of all Artwork Proofs making sure that everything has been accurately made and is suitable for use. This includes that all spelling, grammar, designs, illustrators, images and quality is correct.

The Client is entitled to requesting Approving Proofs to be made again by The Designer, but if The Designer claims there to an excessive number of Approving Proofs being requested (over 5 Approving Proofs), The Client will be charged an extra \$50 for extra work to be produced.

Submission of Client Artwork

The Client understands that the end result and completed version of their Artwork is their responsibility. This includes their own submission of their own artwork to be printed or used. Failure To Preform

If The Photographer is unable to provide photographic services due to illness, mechanical breakdown, accident, acts of God, or any other cause beyond The Photographers control, The Client has the option of rescheduling the shoot, which will have the active deposit and fees still in effect, or cancelling the provided services which will allow The Client to receive all fees, including the deposit, refunded fully.

Agreement of Terms
